New Roles for NWOEA Leaders

NWOEA President Jerry Oberhaus was elected as NEA Director #6 at the OEA Fall RA with his term of office to begin immediately. With a vacancy in the presidency of NWOEA, Vice President Jerry Schlick has assumed the office of NWOEA President until the NWOEA RA this spring when an election will be held to determine who will finish the second year in this unexpired term. No longer the President, Oberhaus will assume the position of Immediate Past-President of NWOEA. At the January 2011 meeting of the NWOEA Board of Directors a new Vice President will be appointed to serve until delegates at the NWOEA RA this April can elect someone to finish the Vice-President's term that expires in August of 2012.

Oberhaus was first elected as NWOEA President by delegates at the 2006 Representative Assembly. Prior to this he served four years as Vice President after first representing Unit I on the NWOEA Executive Committee. He is the Past Chair and member on the Educator Standards Board. Oberhaus is a member of the Liberty Center Classroom Teachers' Association and a teacher of science in the middle school. He received National Board Certification in Early Adolescence Science in 1996. He has served as the Chair of the OEA District Leaders Council since 2006. In 2009 he was in the top 10 as a semifinalist who received the NEA Award of Teaching Excellence.

Schlick from Seneca East has also served many years as a member of the NWOEA Board of Directors and various district committees. In 2003 he was elected to the Executive Committee as a Unit III Representative. In 2006 he ran as Jerry Oberhaus' Vice President in their first bid for NWOEA office. He chairs the Professional Development Committee and is



a member of the Budget Committee and the Internal Affairs Committee. Schlick also spent several years as a member and the chair of the Awards Committee. He is currently serving his ninth year as President of the Seneca East Education Association.

Delegates Encouraged to Fulfill Ohio Education Opportunity Act

On December 4, 2010, the Ohio Education Association, representing 130,000 teachers, education support professionals and higher education faculty, held its Fall Representative Assembly at Veterans Memorial in Columbus. The theme of the Assembly was "The Future of Ohio: Our Opportunity and Our Mission."

In her remarks to the delegates, OEA President Patricia Frost-Brooks said that she and other OEA officials want to meet with Governor-elect John Kasich to listen to his ideas on public education, including K-12, special education, higher education and overall funding for learning in Ohio. Frost-Brooks emphasized to the more than 1,000 delegates attending that the OEA remains committed to the Ohio Education Opportunity Act, passed as House Bill 1 in July 2009.

"The Ohio Education Opportunity Act is a tough-minded set of challenging reforms that called for everyone involved in public education to change, to do better and to do more," said Frost-Brooks. "We embraced this legislation. We fought for its passage. And we fought for the funding and implementation efforts that followed. And it fulfilled our highest hopes for public education in Ohio." Aware of the many challenges ahead in fulfilling the changes of the Ohio Education Opportunity Act, President Frost-Brooks encouraged delegates to work hard and enthusiastically to ensure its implementation.

Special guests Governor Ted Strickland and NEA President Dennis Van Roekel echoed Frost-Brooks in

Retirement Update

September 1, 2009, the State Teachers Retirement Board approved a proposed plan to strengthen the solvency of the pension fund. Fifteen months —

and a few plan modifications — later, we are still awaiting legislation that would enable STRS Ohio to implement the proposed changes. However, there is every reason to believe a bill to revise STRS Ohio's current pension plan design will be introduced in the 129th General Assembly that convenes after the first of the year.

To what extent this legislation reflects the Retirement Board's recommendations won't be known for a while. However, we do know that complicating the pension plan reform discussion will be the dire budget issues facing this state. All of us will need to be mindful of proposals for employer or employee "contribution holidays" or "contribution reductions" as a way to help address the deficit. We also need to be mindful of a possible movement to place future public employees into defined contribution plans.

In my last newsletter article to you, I spoke briefly about the important role defined benefit plans play in helping to maintain financial security for retired public employees in Ohio. In addition, these defined benefit plans help to fuel Ohio's economy. In calendar year 2009 alone, pension benefit payments from STRS Ohio exceeding \$3.9 billion were distributed among Ohio's 88 counties. Defined benefit plans are also both efficient and economical. A 2008 National Institute on Retirement Security Report found that a defined benefit pension can deliver the same retirement income at almost half the cost of a defined contribution account due to pooling of investment risk, continual diversification of assets and professional investment management.

Through its website and e-mail news service, STRS Ohio has shared with members the recent modifications to the pension plan proposal approved by the Retirement Board in October 2010. These modifications provide for the following: • The transition period for a retirement benefit at 35 years of service versus 30 years is now phased in from 2015 through 2023. • There is an option for an actuarially reduced benefit with 30 years of service for members under age 60.

• The cost-of-living adjustment (COLA) will be 2% for both current and future retirees. For those who retire after July1, 2011, however, the COLA will be deferred for 36 months.

The Retirement Board would have the discretion to set a three-, four- or fiveyear final average salary period on the proposed implementation date of August 1, 2015, for this change, based on the actuarial condition of the pension fund at that time.

With the adoption of these changes, the Retirement Board and the system's major constituency groups represented by the Healthcare and Pension Advocates (which includes the OEA) are now united in their support of the proposed reform package and can work collectively for its passage in the Ohio General Assembly.

The changes the Retirement Board has proposed — as fiduciaries of the system — are not popular changes. However, without these changes, STRS Ohio will eventually be unable to pay benefits. It is also important for you to know that any weakening of these changes or delay in their implementation will result in the need for additional changes.

STRS Ohio will use its website and e-mail news service to keep you posted about events at the Statehouse and to let you know when the time is right to contact your legislators. Decisions regarding the future of STRS Ohio won't be made by newspaper reporters and TV station news anchors, but by the members of the Ohio General Assembly. The active and retired members of STRS Ohio will need to work together to help legislators understand that defined benefit plans represent good public policy; they should be emulated, not discontinued.

I would encourage you to do three things as an STRS Ohio member:

(1) Become knowledgeable about the changes proposed by your Retirement Board.

(2) Be ready to explain the value of the STRS Ohio Defined Benefit Plan to you — as a public educator now and as a retiree in the future.

(3) Be prepared to "put a face" on discussions that try to pit taxpayers against public employees. You are also a taxpayer who has chosen public education as a career. Think now about how you can share with your legislators the value of that future pension to you, your family and your community.

OEA Fall RA Highlights

There were 1,046 registered delegates in attendance of which 67 were from NWOEA representing 26 local associations. Contributions to the OEA Fund for Children and Public Education (FCPE) totaled \$32,647.75.

Delegates filled two vacancies on the OEA Board of Directors by electing Jerry Oberhaus from Liberty Center as NEA Director #6 and Robin Jeffries from Columbus City as Board of Director At-Large member.

The delegates voted to adopt three proposals that amended OEA's Constitution and Bylaws.

Proposal #1 will establish the OEA officers' salaries to be based on the second year prior to the budget year. This would match the budget revision passed by delegates last spring at the OEA RA which determined that the budget be based on the average teacher salary from the previous two years.

Proposal #2 removes a list of exceptions to the Code of Ethics of the Education Profession requirement in local, district and affiliated departments, and replaces it with the more general term "IF APPROPRIATE."

Proposal #3, called a "Savings Clause," will give the OEA a remedy if any of the Constitution or Bylaws or its standing rules become contrary to law. Based on the advice of counsel, the board could vote to amend the policy until delegates at the next RA can change it to make it consistent with law.

The 2010-2011 Legislative Policies and the 2010-2011 proposed Education Reform Package were adopted. The Representative Assembly also approved a New Business Item directing OEA to develop and implement a "rapid response" plan to immediately, forcefully, and publicly respond to, and refute, counter attacks on public education and public educators by the media and anti-public groups.

Delegates also adopted the new OEA Vision Statement: "The Ohio Education Association is the hallmark for excellence in education."

NWOEA Teachers Achieve National Board Certification

Three members of NWOEA are among the 81 Ohio teachers to achieve National Board Certification in 2010. More than 8,600 teachers and school counselors achieved National Board Certification this year bringing the total number of accomplished educator by the National Board for Professional Teaching Standards (NBPTS) to more than 91,000. Ohio ranks 22nd nationwide in the number of new National Board Certified Teachers (NBCT's) this year and seventh in the total number of NBCT's over time with 3,268. Forty school districts have at least ten NBCT's with seven of these districts having forty or more.

National Board Certification is the most prestigious credential a teacher can earn. Certification is a voluntary assessment program designed to develop, recognize, and retain accomplished teachers. NBCT's have successfully demonstrated advanced teaching knowledge, skills, and practices through a rigorous, performance-based assessment that typically takes one to three years to complete. As part of the process, teachers build a portfolio that includes student work samples, assignments, videotapes, and a thorough analysis of their classroom teaching. Additionally, teachers are assessed on their knowledge of the subjects they teach. Represent Ohio and Your Local at the 2011 NEA RA

Take an active part in NEA's highest decision-making body and join over 9,000 delegates in the world's largest democratic, deliberative body. Become a representative to the 2011 NEA Representative Assembly to be held in Chicago, Illinois from June 30-July 5, 2011. There are several options for gaining delegate status.

State-At Large Delegates: These delegates are determined by election in each of the three Northwestern Units. The declaration of candidacy form for state delegates is sent to local presidents and is also available through OEA. The form must be filed with OEA no later than January 31, 2011. State delegates will receive at least a \$1000 stipend from OEA to offset expenses at the NEA RA.

Cluster Delegates: Local associations with 75 or fewer members may join together (cluster) with other locals of like-size within the same electoral unit to elect cluster delegates. OEA will determine the "clusters" upon receiving the cluster delegate forms. Interested members may request a Cluster Delegate Declaration Form from OEA. The deadline for filing this form is April 10, 2011. NWOEA provides \$1,500 for each of three cluster delegates (one per unit) and one at-large cluster delegate. Also available this year is the NEA RA Engage Grant to fund an additional delegate eligible for the NWOEA Cluster Delegate status.

Local Association Delegate Status: Local Associations with 76 or more members may elect local delegates to the NEA RA based upon the formula of one delegate per 150 active members or major fraction thereof. NEA will mail official election report forms to presidents of locals with 76 or more members in early February. This completed form must be received at the OEA Offices by April 10, 2011. Funding is determined by the local association's funding policies. NWOEA Local Delegate Assistance to NEA RA Engage Grants provide \$750 of funding to delegates from eligible locals with 76 or more members. The deadline to apply for this Engage Grant is February 1, 2011.

NWOEA Engage Grants Still Available

2010-2011 NWOEA Engage Grants are still available and eligible local associations are encouraged to apply. In order to provide the opportunity for more locals to apply for these grants and be involved in association activities, changes in the eligibility rules have been made.

The FCPE Drive Assistance Engage Grant will provide training, support, and incentives for a local to conduct a Fund for Children and Public Education drive. This grant will reimburse up to \$150 each to two locals per NWOEA unit whose FCPE percentage of member participation was 5% or less last year (2009-2010).

The Local Delegate Assistance to OEA Spring RA Engage Grant will reimburse up to \$100 for overnight lodging and \$50 for mileage to a delegate attending the OEA Spring RA from a local that has not sent delegates to an OEA RA in the previous two school years. Deadline to apply is February 1, 2011.

The Local Delegate Assistance to NEA RA Engage Grant will provide each of the three NWOEA units funding of \$750 for the 2011 NEA RA to a delegate from a local of 76 members or more that has not had a NEA RA delegate in the previous two school years. Deadline to apply is February 1, 2011.

The Cluster Delegate to NEA RA Engage Grant will provide funding for an additional cluster delegate to attend the 2011 NEA RA. Locals of 75 or fewer members who have not had a NEA delegate in the previous two school years are eligible to receive this grant.

Educator Standards Board Update

The Resident Educator Program will begin in the fall of 2011 for all teachers that are licensed after January 1. The program is built on four years of differentiated mentoring based on the Resident Educators' demonstration of practice according to the Ohio Standards of the Teaching Profession. It utilizes formative assessment tools to inform and guide the mentoring as the Resident Educator grows, develops and progresses in their practice. The program also includes a summative assessment tool to measure demonstration of practice which must be at the proficient indicator level of the Ohio Standards of the Teaching Profession (OSTP) to advance to a professional license. ODE will provide some baseline requirements for mentor selection. Locals will have the opportunity to go beyond those baseline requirements. Instructional Mentoring Training is required of all mentors, including those that were trained for the Resident Educator Transition Program.

The Educator Standards Board (ESB) has worked the past year through a writing team and its own standards committee on a model teacher evaluation system. Components of the system are in various

stages of field testing to gather data to inform the final recommendations in late spring. The framework of the Ohio Model Teacher Evaluation includes self assessment opportunities using the OSTP and analysis of student data. Components include a goal setting and professional growth plan, formal observation processes, and coaching and formative assessment opportunities, as well as the collection of artifacts as evidence indicators, and a written summative evaluation. The process would differ slightly for teachers that are in the first seven years of their career compared with those that have been teaching eight years or more.

As referenced in the Teacher Evaluation Components, the Ohio Education Opportunity Act also directs the ESB to propose recommendations for metrics of measurement for academic growth. This language replaced what was originally in the bill as value-added data. The measures of academic growth are to be a component of multiple measures that inform eligibility for licenses, the Ohio Resident Educator Program, and Model Teacher and principal evaluation processes. There is still a strong emphasis from many directions to use value-added data. We know that the student performance data must come from a variety of sources, must take place over time, and must be teacherdriven. The primary framework

recommendation will be formed in late spring. The full body of the ESB will be working on the recommendations for measures of academic growth. Areas of pupil performance data that must provide opportunities from all educators not just the core subjects, include teacher designed formative and summative assessments, grade level subject assessments, portfolios, performances, products and mastery tasks, and standardized test scores and value added data when available.

The ESB Standards Committee is working with a writing team to collect the best practices of PAR that we already have in our state. From the examples that we have studied within our state we will have a recommendation for model PAR components. There are some essentials to successfully building and implementing a PAR program. They include an appropriate climate within the district, a defined governance structure to oversee the PAR, clear processes and procedures, and of course quality training.

The ESB Licensure Committee has begun review of the Ohio Standards for the Teaching Profession which were adopted five years ago. The Standards will not change but the ESB may make modifications to language in the indicators that clearly identify growth and issues of linguistics, English language learners, as well as 21st century skills terminology.
