#### **NWOEA Endorses Myers and Oberhaus**

During the NWOEA Caucus at the OEA Fall RA, delegates unanimously endorsed Tim Myers from Elida and Jerry Oberhaus from Liberty Center. Tim is running as a candidate for the position of OEA Secretary-Treasurer, and Jerry is running for re-election as a candidate for the NEA Director #6 position. The election for both will be held at the OEA Spring RA on May 11, 2012.

Tim is currently a computer science and science teacher in his 29th year of teaching for Elida Local Schools, his alma mater. Serving as NWOEA's Unit II Representative on the OEA Board of Directors, he is a member of the NWOEA Board of Directors. Tim has held NWOEA

district offices of President, Past-President, and Vice-President and served as an NEA Director. He is an STRS Board Member and Past Chair. Other leadership experiences include the Chair of NEA's Trustee Pension Caucus and the Legislative Committee Member of the National Council of Teacher Retirement Systems.

Tim shared his three goals as Secretary-Treasurer of OEA:

1) Strategic Budget: "We need to continue to base our budget on the needs of our members. Using the OEA Strategic Plan, we can determine what programs to offer. Using a strategic budgeting process allows us the flexibility to evaluate these programs since costs are tied to results. As one of the seven members of the NEA Budget Committee, we started with the programs our members needed most and then figured out how to fund them. I have the training needed to continue to move the OEA in this direction."

2) STRS: "I will work with your own Carol Correthers and the other board members to actively search for solutions to the health care crisis, specifically through the work of the Health and Pension Advocates for STRS. As a member of the STRS Board, I am in a unique position to continue to work to find common solutions

### **OEA Delegates Celebrate Defeat of Issue 2**

Delegates set the mood for the 2011 OEA Fall Representative Assembly on Saturday, December 3, with their cheers of jubilation and loud applause to celebrate the defeat of Issue 2, which repealed Senate Bill 5 (SB 5). They viewed a video that covered the entire campaign, starting with the rally in January when opponents of SB5 were locked out of the State House and ending with the announcement that Issue 2 was defeated. In her remarks to the delegates, OEA President Patricia Frost-

Brooks thanked the OEA members for all their efforts to defeat Issue 2, which included countless miles of canvassing and long hours of phone banking.

NEA President Dennis Van Roekel addressed the delegates and also commended the OEA members for their hard work to protect collective bargaining. Although the campaign to defeat Issue 2 was crucial to OEA members, it was also closely watched and extremely important to all NEA members.

#### NWOEA Appoints New Members

At the September Board meeting the NWOEA Board of Directors appointed Sue Cramer and Rozalind Herzig to fill vacancies. Sue will serve as a Unit II Representative and Rozalind will serve as a Unit I Representative until August 31, 2012.

that are fair to both retired and active members. I will also work with all of our ESP members (including your own SERS board member, Beverly Woolridge) to improve the health care and benefits for ALL OEA MEMBERS."

3) OEA's Message: "We need to mobilize ALL of our 3.2 million NEA members in our effort to get the message of public education out to the voters. This past election showed what we can do when we work together. My plan involves face-to-face conversations with many of OEA's affiliates before the November 2012 elections to show the need for FCPE drives and electing pro-public education candidates."

Jerry is running for re-election as NEA Director #6, a position to which he was elected by the delegates at the 2010

OEA Fall RA. He is the Past-President of NWOEA after serving over four years as the District President. He has also held the positions of NWOEA Vice-President and Unit II Representative on the Board of Directors. Jerry is currently serving as a Member and the Past Chair of the Ohio Educator Standards Board. In his twenty-fifth year of teaching and a National Board Certified Teacher, Jerry is currently instructing science at Liberty Center. In 2009 he was OEA's nominee for the NEA Foundation Award for Teaching Excellence and received The I Can Learn Award for Teaching Excellence.

#### **Retirement Update**

#### Strategic Planning under Way for Pensions and Health Care

In previous newsletters, I have provided you with

updates on STRS Ohio's proposed plan to strengthen the financial condition of the pension fund. As you may recall, the plan calls for changes that will affect both active teachers and retirees. The plan is contained in S.B. 3 and H.B. 69 that are on hold while the Ohio Retirement Study Council (ORSC) studies the plans submitted by all five Ohio public retirement systems. The ORSC recently selected an independent actuarial firm, Pension Trust Advisors, to review and advise the Council on the pension reform plans. STRS Ohio will cooperate with the study, while we continue to review data on the health of the pension and health care funds and determine what steps are needed to meet our fiduciary responsibility to our members.

In November, the Retirement Board's actuarial consultant, Pricewaterhouse Coopers (PwC), reviewed the results of the 2011 annual actuarial valuation report. The report indicated the pension system's funded ratio stands at 58.8% – down from 59.1% last year. PwC noted that as retirement systems mature, it is common for these funds to experience negative cash flow – that is, for benefit payments to exceed contributions collected. However, PwC said that it is happening at a faster than projected rate at STRS Ohio due to an uptick in retirements (more benefits are being paid) and slower

growth than expected in teacher payrolls (fewer contributions).

Also in November, the Retirement Board's investment consultant, Callan Associates, updated the board on its ongoing asset-liability study that began in August. As part of the study, Callan is providing both long-term and short-term capital market projections. Callan concluded that STRS Ohio's current investment policy target would be challenged to achieve an 8% return for the next five and perhaps 10 years. However, Callan reported that based on this investment policy target and historical data, STRS Ohio could expect to generate an 8% to 8-1/2% return over the longer-term 30-year horizon.

The Retirement Board will analyze how the new actuarial data, along with the asset-liability study, will impact its proposed plan to reach the statutory requirement of a 30-year funding period. Some elements of the board's plan are scheduled to go into effect on July 1, 2012. If legislation is not passed in time for a July 1 implementation, the 30-year funding requirement will again be in jeopardy. If further changes are necessary, the board will review its alternatives in the coming months.

The board is also committed to another important retirement benefit that STRS Ohio offers, our health care program. Unlike the pension benefit, health care is not a statutory requirement. However, the Retirement Board along with STRS Ohio staff is looking at options to extend the long-term life of the Health Care Stabilization Fund. The board wants to be able to continue to

offer health care and make it something retirees and even active members can rely on in the future. The board and staff are developing a long-term strategic plan that will include specific initiatives for 2012 through 2015.

In a recent presentation to the board, STRS Ohio staff data projects that the current health care program is only expected to remain solvent until 2024, and there is little prospect for additional funding. The board also learned that 69% of benefit recipients enrolled in the STRS Ohio Health Care Program also receive Medicare benefits, while 31% are non-Medicare – yet subsidies for non-Medicare retirees account for 62% of all subsidies.

With this in mind, staff proposed a vision for the future that would establish the Medicare program as the cornerstone for the STRS Ohio Health Care Program – to help the largest number of retirees for the longest period of time. This plan would increase out-of-pocket expenses to reduce premium increases and merges the Medical Mutual Plus and Basic plans into one plan by 2016. The most significant changes would affect the non-Medicare program. These changes would more closely align costs with the marketplace.

In the coming months, staff will present a more detailed plan concerning health care for the board's review. We will be discussing this plan along with the fiscal strength of the pension fund in future board meetings before taking any action. #### **OEA Fall RA Highlights**

There were 1,029 registered delegates in attendance of which 67 were from NWOEA representing 27 local associations and the NWOEA-Retired. Representing NWOEA, the Gibsonburg High School Golden Notes Jazz Band provided the pre-RA entertainment and played the National Anthem for the opening ceremonies. Contributions to the Fund for Children and Public Education totaled \$33,704.

Delegates elected Tammy Koontz to

fill the OEA Board of Directors At-Large position for a term ending August 31, 2013. They also adopted the proposed 2011-2012 Legislative Policies and the Systemic Policy Agenda of the Ohio Education Association: Supporting a High-Quality Public Education System in Ohio, formerly titled the Education Reform Package. The new Systemic Agenda is the OEA vision for a high-quality system of public education that acknowledges the right of every child to an opportunity for a high-quality education and supports educators,

communities, and policymakers in creating such a system.

Delegates approved two new business items. New Business Item #1 directs OEA to continue to develop appropriate and necessary action plans that strengthen the role of the local associations, OEA District Associations and Regional Coordinating Councils. New Business Item #2 directs OEA to remind members about who voted for and against Senate Bill 5 with "Remember Issue 2" literature.

#### Become a Representative to the 2012 NEA RA

Take an active part in NEA's highest decision-making body and join over 9,000 delegates in the world's largest democratic, deliberative body. Become a representative to the 2012 NEA Representative Assembly to be held in Washington, D.C. from June 30-July 5. There are several options for gaining delegate status.

#### **State-At Large Delegates:**

These delegates are determined by election in each of the three NWOEA Units. The declaration of candidacy form for state delegates is sent to local presidents and is also available through OEA. The form must be filed with OEA no later than January 31, 2012. State delegates will receive a stipend of approximately \$1,500 from OEA to offset expenses at the NEA RA.

#### **Cluster Delegates:**

Local associations with 75 or fewer members may join together (cluster) with other locals of like-size within the same electoral unit to elect cluster delegates. OEA will determine the "clusters" upon receiving the cluster delegate forms. Interested members may request a Cluster Delegate Declaration Form from OEA. The deadline for filing this form is April 10, 2012. NWOEA provides up to \$1,500 for each of three cluster delegates (one per unit) and one at-large cluster delegate.

#### **Local Association Delegate Status:**

Local associations with 76 or more members may elect local delegates to the NEA RA based upon the formula of one delegate per 150 active members or major fraction thereof. In early February, NEA will mail official election report forms to presidents of locals with 76 or more members. This official report form must be received at the OEA Office by April 10, 2012. Funding is determined by the local association's funding policies.

#### **Engage Grant Provides Assistance** to **OEA Spring RA**

To help locals become involved in the Association at the state level and to provide support for NWOEA candidates running for election at the OEA Spring RA, NWOEA is offering the Local Delegate Assistance to OEA Spring RA Engage Grant. This grant provides funding to reimburse \$100 for overnight lodging and \$50 for mileage to the OEA Spring RA for one delegate from a local that has not sent delegates to an OEA RA in the previous two school years.

Funding will be given on a first-come, first-serve basis until funding is exhausted. Preference will be given to delegates who attended the OEA Fall RA and whose local has the highest percentage of member participation in the Fund for Children and Public Education as of December 31, 2011. Receipts would be required for reimbursement of up to \$150.
