The NWOEA Board of Directors filled several vacancies at its September meeting. Appointed to the Board for the first time were Perry Lefevre as a Unit I Representative and Donald Jones as a Unit III Representative. Jerry Oberhaus was also appointed to fill the Unit II seat on the OEA Board of Directors, vacated by Tim Myers who was elected as the OEA Secretary-Treasurer. All three appointees will serve until the next NWOEA RA to be held April 11, 2013 when elections will be held for these positions.

Perry Lefevre currently serves as the President of the Sylvania Education Association, a role he held previously from 2000 to 2006. He has taught social studies at Sylvania Northview High School for the past twenty-five years. Having served on his local's negotiations team for twenty-two years, NWOEA was pleased to recruit Perry to serve as the NWOEA Representative on the OEA Collective Bargaining Core Function Committee. He has been a local delegate at the OEA RA's for twenty years.

He is currently the secretary for his local association, a position he has held for eleven years, and a member of the negotiations team for the past two contracts. #### 2012 OEA Fall RA The Future of Ohio - Our Opportunity and Our Mission



The 2012 Ohio Education Association Fall Representative Assembly was held December 1, 2012, at Veterans Memorial Auditorium in Columbus. The theme of this year's RA was *The Future of Ohio - Our Opportunity and Our Mission*.

Delegates overwhelmingly voted to join forces with the Strong Schools, Strong Communities Campaign. This campaign is a citizen-driven, non-partisan movement dedicated to informing and engaging Ohioans to tell the stories of excellence and achievement in public schools throughout Ohio - schools that deserve support from their communities and from state government.

Delegates gave a warm reception to eleven OEA member candidates who ran for the Ohio House. Ohio Senate. and the State Board of Education in the Fall 2012 election. "OEA is committed to electing representatives who understand and support public education in Ohio," said OEA President Patricia Frost-Brooks. As John Patterson of Painesville, our newly elected member legislator told the RA, "Each of you, each and every one of you, possesses the potential to take the challenge as we did in running for office." Brooks promises members that a tremendous amount of training, planning, and resources await members who decide to throw their hat in the ring.

The OEA President also outlined some of the many new changes and mandates in the education profession such as the new teacher evaluation process, the Common Core curriculum

## **OEA Fall RA Highlights**

Of the 986 registered delegates in attendance at the 2012 OEA Fall Representative Assembly, 64 were from NWOEA, representing 28 local associations and the NWOEA-Retired. Contributions to the Fund for Children and Public Education totaled \$33,535.54.

Delegates elected Robin Jeffries from Columbus EA to fill the NEA Director #6 position. They adopted the proposed 2012-2013 Legislative Policies for Achieving Excellence in Education (including the addendum) and the 2012-2013 proposed Systemic Policy Agenda of the OEA. They also adopted Proposal 1 to amend OEA Bylaws 8-1, Divisions, to apply the Bylaws to the proper Divisions. The amendment restates the language regarding the structure of the Divisions of Higher Education, Ohio Student Education Association, and OEA Retired to conform to longstanding practices.

Delegates approved the following three new business items:

• OEA shall create a committee comprised of governance, staff, and members to form a strategy, organizing, and messaging plan to defeat any potential Right-to-Work legislation and/or ballot initiative; with a comprehensive plan to be presented by the next OEA RA.

• The OEA shall provide a tool kit to all locals that will enable locals to actively engage in the Strong Schools Strong Communities organization. The toll kit should include a sample resolution the local can adopt, a sample news release for the local to send to media, recommended ways to engage the local community as well as other education stakeholders in this effort to secure proper funding for public education and to demonstrate through education success stories how Strong Schools create Strong Communities. This effort shall be started as soon as possible.

• The OEA, through appropriate leaders and staff, shall develop and promulgate among local affiliates a set of collective bargaining recommendations including model policy and contract language and specific bargaining strategies on implementation of the Ohio Teacher Evaluation System and Reduction-in-Force provisions related to HB 153 in order to maximize protection of member rights and the best interest of students. ■

with new standards and tests, the newly adopted Third Grade Reading Guarantee, new legislation raising the bar for school district report cards and the punitive attitudes hanging on from No Child Left Behind.

As Congress prepares for a political showdown in Washington, OEA Executive Director Larry Wicks addressed the delegation, warning that the looming fiscal cliff has dire consequences if Congress fails to act for Ohio's students. The fiscal cliff includes \$147.6 million in cuts to education in Ohio, and that means 60,000 Ohio students would lose learning opportunities, ranging from Head Start and preschool to adult literacy education and higher education.

During the RA lunch break, delegates had the opportunity to attend a colloquium on teacher evaluation, *Navigating OTES - Fall 2012 OEA RA*. This presentation highlighted the requirements for the Ohio Teacher Evaluation System and outlined approaches to member advocacy. To accommodate the wide interest in the evaluation procedures, OEA had to move the presentation to the big auditorium at Vets Memorial. Sandusky St., Suite 302, Findlay, OH 45840. The deadline for filing letters of intent is February 8, 2013.

If you are interested in the OEA Board of Directors position(s), contact your local president or Carol Price at OEA Headquarters, (1-800-282-1500 or pricec@ohea.org) and request a Declaration of Candidacy Form. The OEA form must be received in Columbus no later than January 26, 2013, and a copy of the form should be sent to the NWOEA Center.

### **NWOEA RA Schedule Includes Delegate Orientation**

First-time delegates attending the NWOEA Representative Assembly at Findlay High School in Findlay on April 11, 2013, are encouraged to attend a brief orientation session prior to the RA. Local presidents are asked to mark firsttime attendees on the NWOEA delegate verification form so that the new delegates will receive notification of the orientation session. This session is also open to veteran delegates, if they wish to attend.

Doors open at 5:00 PM and sandwiches and snacks will be available at this time. The tentative start time for the orientation is 5:15 PM. The first RA session begins at 5:45 PM and registration closes at 6:00 PM. Deadline for submission of New Business Items and Resolutions is 6:30 PM. The OEA Delegate Briefing will be held concurrently with the NWOEA RA. ■

### The Role of the NWOEA RA Delegate

The Association is governed by Representative Assemblies (more commonly called RAs) at all levels national, state, and district. Delegates to these meetings elect officers, adopt budgets, approve governing documents, and set the policies that determine the direction of the Association. Locals that do not send delegates to the Representative Assemblies are forfeiting the rights they have as a member of a democratic organization.

OEA delegates attend the OEA RA in the fall and in the spring. They are also automatically seated as delegates at the NWOEA Representative Assembly. In addition to a local's OEA delegates, each local is entitled to elect delegates who attend only the NWOEA RA on April 11, 2013. Attendance as a NWOEA delegate to the NWOEA RA is an excellent way to introduce and involve new leaders in the democratic process. Some locals have their OEA alternates become NWOEA delegates. This way the OEA alternates who are also NWOEA delegates are seated at the NWOEA RA and are prepared to go to Columbus in the event that their OEA delegate cannot fulfill their obligations.

Locals must report their NWOEA delegates to the NWOEA Center. Certifying state delegates to OEA does not certify NWOEA delegates. The deadline for the election of NWOEA delegates and alternates is Friday, February 1, 2013. The deadline for submitting names of NWOEA delegates and alternates to the NWOEA Center is Friday, February 8, 2013.

#### Engage Grant Provides Funding to OEA Spring RA

NWOEA is offering again this year the Local Delegate Assistance to OEA Spring RA Engage Grant. This grant helps locals to become involved in the Association at the state level by providing funding to a local that has not sent delegates to an OEA RA in the previous two school years. One delegate from an eligible local can receive reimbursement of \$100 for overnight lodging and \$50 for mileage to the OEA Spring RA. Funding will be given on a first-come, first-serve basis until funding is exhausted. Preference will be given to delegates who attended the OEA Fall RA and whose local has the highest percentage of member participation in the Fund for Children and Public Education (FCPE) as of December 31, 2012. Receipts would be required for reimbursement of up to \$150. Any delegate interested in applying for this grant should submit a letter of interest including delegate contact information and local association president's signature. For many months I have been providing updates on pension reform legislation that would impact all public school educators in Ohio. In September, the Ohio Legislature passed Substitute Senate Bill 342, along with four other pension bills that will affect most public sector workers in the state. As I've noted before, these difficult, but necessary changes will improve the funding position of STRS Ohio.

The key components of the new law were outlined in STRS Ohio's October newsletters and are also detailed on the system's website at **www.strsoh.org**. The changes include:

- Increasing age and service requirements for retirement;
- Reducing the benefit formula for years of service;
- Increasing member contributions;
- Increasing the period for determining final average salary; and
- · Changes to the cost-of-living adjustment

The new law is effective on January 7, 2013, but most of STRS Ohio's changes will take effect July 1, 2013, or later. If you are approaching retirement and need more specific information about how these new provisions affect you, I encourage you to set up a one-on-one counseling appointment with an STRS Ohio benefits counselor. Appointments are available in the Columbus office, in field counseling locations throughout Ohio, or through a TeleConference that you can participate in from your own home. You can schedule

**Retirement Update** Pension Reform Legislation Passed: Retirement Board Eves Next Steps

> Now that the new law has passed, the Retirement Board is turning its attention to health care strategic planning, as well as how pension reform will affect members in STRS Ohio's Defined Contribution and Combined Plans. Pension reform laws primarily addressed STRS Ohio members who are enrolled in the Defined Benefit Plan, but members who are enrolled in STRS Ohio's Defined Contribution (DC) Plan or Combined Plan will also be affected.

> The Retirement Board is reviewing potential changes to the DC and Combined Plans that recognize the need to fund the system's unfunded accrued liability. STRS Ohio will communicate any changes to these plans through its newsletters and website.

> On the health care front, the board's focus is how to extend the solvency of the Health Care Stabilization Fund - trying to balance plan solvency and a plan that offers meaningful benefits, while continuing to attract and retain healthy members to the plan.

The board has identified three primary goals for its health care strategic plan:

- Establish Medicare as the health care program's cornerstone, to help the largest number of retirees for the longest period of time;
- Achieve 30 years of solvency for the health care program by 2016 (the program is now projected to be solvent until 2039); and
- Extend forecasted solvency to 65 or more years by 2025.

As STRS Ohio looks for ways to extend the solvency of the Health Care Stabilization Fund, it is also important to evaluate just how the Affordable Care Act (ACA) will shape the health care

Health care exchanges - a key component of the ACA - are expected to provide guaranteed issue coverage for pre-Medicare individuals, but it is still unclear how these exchanges will develop in Ohio and how they might impact the STRS Ohio Health Care Program. STRS Ohio staff will monitor the ACA and how we might use it to have a positive effect on the long-term strength of the health care program.

STRS Ohio will continue to use its website, newsletters and eUPDATE email news service to keep its members, employers and stakeholders informed about pension and health care issues.

As a closing note, I would like to remind you that the State Teachers Retirement Board election will be held this spring for one contributing member seat and two retired members seats. If you are an active member, you can only vote for the contributing member seat, and retirees can only vote for the retiree seats. Please watch for your ballot in April and exercise your right to vote.

# **Options for Gaining Delegate Status for 2013 NEA RA**

Take an active part in NEA's highest decision-making body and join over 9,000 delegates in the world's largest democratic, deliberative body. Become a representative to the 2013 NEA Representative Assembly to be held in Atlanta, Georgia from July 1-6, 2013. There are several options for gaining delegate status.

**State At-Large Delegates:** These delegates are determined by election in each of the three Northwestern Units. The declaration of candidacy form for state delegates is sent to local presidents and is also available through OEA. The form must be filed with OEA no later than January 31, 2013. State delegates will receive a stipend of approximately \$1,500 from OEA to

offset expenses at the NEA RA.

**Cluster Delegates:** Local associations with 75 or fewer members may join together (cluster) with other locals of likesize within the same electoral unit to elect cluster delegates. OEA will determine the "clusters" upon receiving the cluster delegate forms. Interested members may request a Cluster Delegate Declaration Form from OEA. The deadline for filing this form is April 10, 2013. NWOEA provides approximately \$1,500 for each of three cluster delegates (one per unit) and one at-large cluster delegate.

Local Association Delegate Status: Local Associations with 76 or more members may elect local delegates to the NEA RA based upon the formula of one delegate per 150 active members or major fraction thereof. NEA will mail official election report forms to presidents of locals with 76 or more members in early February. This official report form must be received at the OEA Office by April 10, 2013. Funding is determined by the local association's funding policies.
