2013 OEA Fall RA Educators Rock!

The 2013 Ohio Education Association Fall Representative Assembly was held December 7, 2013, at Veterans Memorial Auditorium in Columbus. The theme of this year's RA was *Educators Rock!*

Conducting her first representative assembly, OEA President Becky Higgins encouraged delegates to feel the joy that moved them to join the profession, reflect on the satisfaction that comes when they inspire young minds, take a bow for their success in motivating their students, and give a high-five to their colleagues for their achievements. She stressed that 2014 will be a very important year voters in Ohio will choose the next governor, a decision that will have major consequences. In November OEA held a special convention of the Fund for Children and Public Education so a gubernatorial endorsement could be made and OEA could begin the task of putting a friend of education in the Governor's office.

Delegates gave a warm reception to Ed FitzGerald, OEA's endorsed candidate for Ohio Governor. As a friend to education, FitzGerald believes "we need to honor and respect educators."

For OEA Executive Director Larry Wicks, this OEA RA was his last opportunity to address the delegates as he will be retiring December 31, 2013, after 47 years in education. Wicks has served as OEA's director since November 2008. He continues to serve as chairperson of the Executive Committee for We Are Ohio, the coalition that successfully overturned Senate Bill 5 in 2011 through a No vote on Issue 2. This year, under his continuing leadership, We Are Ohio is working to prevent passage of the so-called "Right to Work" amendment.

As 2013 comes to a close, I reflect back on the past three years and I become angry and frustrated at what has happened to public education in our state since Governor Kasich has taken office. NEA President Dennis VanRoekel, attended the RA to participate in the tribute to outgoing Larry Wicks. VanRoekel praised Wicks for his tireless work for the members of OEA.

Delegates welcomed Sheryl Mathis, who joined OEA as of December 1 to learn the ropes before taking over as OEA's new Executive Director on January 1, 2014. Mathis previously served six years as executive director of the Arizona Education Association and eleven years as associate executive director for the Kansas NEA with responsibility for field operations. She brings over seventeen years of state affiliate management experience to the executive director position. She informed delegates that she "comes from Arizona, a Right to Work state, and Ohio does not want to go there."

Funding Increased for OEA Spring RA Engage Grant

NWOEA has increased the funding from \$150 to \$250 for the Local Delegate Assistance to OEA Spring RA Engage Grant. This grant helps locals to become involved in the Association at the state level by providing funding to a local that has not sent delegates to an OEA RA in the previous two school years.

One delegate from an eligible local can receive reimbursement of up to \$250 for overnight lodging and mileage to the 2014 OEA Spring RA. Funding will be given on a first-come, first-serve basis until funding is exhausted. Itemized receipts are required for reimbursement.

Any delegate interested in applying for this grant should submit a letter of interest including delegate contact information and local association president's signature. Letters should be sent by March 7, 2014, to the NWOEA Center, 101 W. Sandusky Street, Suite 302, Findlay, Ohio 45840. ■

OEA Fall RA Highlights

Despite the bad weather due to a winter storm, 58 delegates representing 22 local associations in NWOEA and NWOEA-Retired were among the 771 registered delegates in attendance at the 2013 OEA Fall Representative Assembly. Contributions to the Fund for Children and Public Education totaled \$36,890.15.

Delegates voted overwhelmingly to adopt a new legislative policy stating that teachers and other school employees should not be asked to serve a dual role as educators and school safety personnel armed with weapons. This school safety policy adopted by the OEA also urges that appropriate assistance be provided for mental health services for students as part of a comprehensive program to prevent school violence. In an informal survey, some 70% of the delegates at the RA reported that they were not being consulted by their local school districts in the development of school safety plans.

In addition to the proposed 2013-2014 Legislative Policies for Achieving Excellence in Education (including the addendum), delegates also adopted the 2013-2014 proposed Systemic Policy Agenda of the OEA. Emilly Osterling from Lakota Local Schools (Butler County) was elected to fill the NEA Director #1 position with term ending August 31, 2014. Delegates also approved the following two new business items:

- The delegates to the December 2013 OEA RA authorize the OEA Board of Directors and Executive Director to engage Ohio's education stakeholders and advocates for children and families, to join the OEA in seeking to redefine the renewal and improvement of public education, and to do so through research-informed practices that address the appropriate use of assessments, de-emphasize massive standardized testing and respect the aspirations, talents and needs of educators and students.
- The OEA should consider a dues reduction when an affiliated association goes on strike. \blacksquare

The Role of the NWOEA RA Delegate

The Association is governed by Representative Assemblies (more commonly called RAs) at all levels – national, state, and district. Delegates to these meetings elect officers, adopt budgets, approve governing documents, and set the policies that determine the direction of the Association. Locals that do not send delegates to the Representative Assemblies are forfeiting the rights they have as a member of a democratic organization.

OEA delegates attend the OEA RA in the fall and in the spring. They are also automatically seated as delegates at the NWOEA Representative Assembly. In addition to a local's OEA delegates, each local is entitled to elect delegates who attend only the NWOEA RA on April 10, 2014. Attendance as an NWOEA delegate to the NWOEA RA is an excellent way to introduce and involve new leaders in the democratic process. Some locals have their OEA alternates become NWOEA delegates. This way the OEA alternates who are also NWOEA delegates are seated at the NWOEA RA and are prepared to go to Columbus in the event that their OEA delegate cannot fulfill their obligations.

Locals must report their NWOEA delegates to the NWOEA Center. Certifying state delegates to OEA does not certify NWOEA delegates. The deadline for the election of NWOEA delegates and alternates is Friday, January 31, 2014. The deadline for submitting names of NWOEA delegates and alternates to the NWOEA Office is Monday, February 10, 2014.
