AFSCME case.

FCPE CONVENTION – Members attending the FCPE (Fund for Children and Public Education) convention held on March 10, 2018 at the Crown Plaza Hotel in Dublin, Ohio discussed the endorsement of candidates running for state offices as well as for open seats in the House Districts and the Congressional Districts. All OEA-R and NWOEA-R members are encouraged to donate to FCPE, as it is important that we elect education friendly legislators no matter what party they represent. Teachers, students, and support staff deserve legislators who are committed to public education and will act in the best interests of educators and our students.

# **LEGISLATIVE UPDATES**

- The case being heard by the U.S. Supreme court referred to as the Janis v. AFSCME Case is legally challenging unions about having fair share. If the Supreme Court favors this law, no school district or public institution is allowed to deduct dues out of paychecks of employees who choose not to join the union but enjoy the benefits of union representation at the bargaining table.
- Ohio House Bill 512 will allow legislators and the governor to combine the Ohio Department of Education (ODE), the State Board of Education (OSBE), and the Ohio Workforce and Employment/career Development Offices. The promoters of this bill believe this new combined agency will be best for companies who are looking for skilled workers pursuing technology careers. The ODE and OSBE would no longer be making important educational decisions for Ohio public schools/institutions as they would only oversee teachers' licensures and the Ohio Teacher Evaluation System (OTES) issues.
